

For 24 years Joey and Danny have travelled to the Poland Springs bottling company to bring the pallets back. The Lobster Pound's forklift and driver loaded pallets into pickup trucks and trailers but once at the firehouse, unloading 78 cases of 24 bottles is by hand!

Board of Selectpersons Minutes Community Building 5/15/24

<u>Attending</u>: Hilly Crary (chair), Diana Gazis, Rob Wilpan, 5 in person. The laptop was not working properly so ZOOM was not used.

<u>Call to order, good news report.</u> The meeting was called to order at 7:07 PM. The good news was that the FEMA helper assigned to us for reimbursements for repair of January storm damage is the same individual who was assigned to us and has helped with obtaining reimbursements for the repair of damage caused by the December storm.

Adjustments to the Agenda. There were no adjustments to the agenda.

Approval of Minutes of the 5/1/24 and 5/8/24 selectboard meetings. The minutes of the two previous selectboard meetings were approved and then signed. The motion to approve was made by Diana Gazis, seconded by Hilly Crary and passed, Crary aye, Wilpan aye, Gazis aye.

<u>Disbursement Warrant #22</u>. A motion to approve Disbursement Warrant #22 was made by Hilly Crary, seconded by Diana Gazis, and passed: Gazis aye, Crary aye, Wilpan aye. The warrant and payroll were then signed.

<u>Candidate questionnaire.</u> The town's questionnaire for candidates was sent twice to the one candidate for selectman, Myles Bierman. It was not filled out and returned, either on paper or digitally.

<u>Town Pier power and Webcam update.</u> Bud Lee Electric has been given the contract to repair the lighting at the town pier and is starting this repair. We have no cost estimate for buying a webcam for the harbor. We decided to put off placing this purchase on the town warrant until next year because on this year's warrant we have too many other expenses.

<u>Sand and salt shed electricity update</u>. We have shut off all breakers, and the meter in the sand and salt shed shows no current. Now we will wait to see if the next bill for electricity corresponds to what is expected when having no current.

<u>December Storm FEMA update.</u> Hilly has signed off on the December FEMA paperwork. We had high costs for removal and chipping of downed trees because we have no town crew for this.

<u>Roads/culverts/ditching Inventory update</u> Steve Schley has a lot of photos of Sorrento's roads, ditches, and culverts which he is putting on the Town laptop for a database.

<u>Digital Traffic Speed Sign.</u> This sign will be put out by Joey Clark, in consultation with Rob. <u>Set a date for another special selectboard meeting to work on Annual Warrant and Town</u>

<u>Report.</u> Two dates were set: Monday May 20 and Thursday May 23, both at 7 PM in the Town Office.

At 7:30 pm: A motion was made, seconded, and passed for an executive session pursuant to IMRS 405 (6) E – consultation with legal counsel . An executive session with attorney Patrick Lyons was then conducted.

<u>Meeting Adjournment</u> The meeting was adjourned at the end of the executive session: 8:39 PM.

Dog Licenses

*Dogs must be licensed by January 1 of each year or when they reach 6 months of age. \$6 for neutered/spayed... \$11 for unaltered

**Any dog living in the Town of Sorrento must have a <u>Sorrento</u> license/tag.



***When licensing your dog, you must bring with you your dog's rabies certificate showing the tag number and date of expiration and your certificate of proof of spay or neuter, unless these are already on file at the Town Office.

Online licensing is available October 15 thru January 31 www.apps1.web.maine.gov

Starting February 1 a fine of \$25 will be due along with the registration fee on any unregistered dog. If you no longer own a dog that was registered last year, please call the Town Office to update our records.



When transferring your auto registration from your vehicle to a new/newer vehicle, you MUST bring in the registration of the vehicle you are transferring from.

EXPIRATION DATES

VEHICLES: Expire a year from when they are registered (unless you are transferring) TRAILERS: Can be registered for 1 or 2 years, same month, except over 2000 lb. Trailers expire in Feb. (1 or 2 years) **BOATS:** Expire Dec. 31st ATVs: Expire June 30th **SNOWMOBILES:** Expire June 30th

MOTORCYCLES: Expire March 31 of every year, except antique

BURN PERMITS

You are required by Maine law to have a permit to burn, even for a small pile of grass clippings or leaves. <u>A Forestry Warden will be called if you burn without a permit, possibly resulting in you being summonsed to court and fined.</u>

The person who signs the fire permit is responsible for the fire. Do not leave any fire unattended. To obtain a burn permit contact:

at least **two adults to attend the burn,

**some form of water supply and hand tools must be on hand,

**and it is recommended you have a cellular phone or other communication device to call for assistance should the fire escape.

YOU are responsible to see that the fire is out before leaving.

TAKE NOTE BURNING TRASH IS ILLEGAL!!

State Laws (12 MRSA 9321-25) governing the backyard burning of household trash are enforced by the Maine Forest Service.

If you think someone is burning trash please call 973-3700 immediately! 24 hours/day, 7 days a week.

ONLINE BURNING PERMITS

Traditional hand-written burn permits are still available, but the state online system allows permits to be acquired 24 hours a day, seven days a week, throughout the state, provided that the fire danger is not high. For more information, call 287-4989 or visit www.maineburnpermit.com.
