- To see if the Town will vote to raise \$20,000 and appropriate 10,000 from surplus for the Capital Improvement Fund which is dedicated to the purpose of paying for high cost capital improvement expenditures incurred by the Town without abruptly raising taxes or obtaining loan. **MOVED**, 2ND, **VOTED**, **PASSED**
 - 10. To see if the Town will vote to raise \$8,000.00 for the Comprehensive Planning Committee. This money is needed to pay for required personnel help which is to be provided by the Hancock County Planning Commission. MOVED, 2ND, AMEND TO 'RAISE AND APPROPRIATE'. AMENDMENT VOTED, PASSED. VOTE ON ARTICLE AS AMENDED, PASSED.
 - To see if the Town will vote appropriate 25,000 from the Capital Improvement Fund. This money is to be used along with a matching grant from the Small Harbor Improvement Program (SHIP). This pier will help aide the fisherman with traps and bait and also others while loading and unloading boats at the town landing. MOVED, 2ND, AMEND TO READ AFTER 'CAPITAL IMPROVEMENT FUND' TO BUILD FLOATS. TAKE OUT THIS PIER TO READ THE FLOATS. PUT \$ ON 25,000. AMENDMENTS VOTED & PASSED. VOTE ON ARTICLE WITH AMENDMENTS, VOTED, PASSED.
 - 12. To see if the Town will vote to amend the Sorrento Harbor Ordinance by removing Section 6.2.
 - 6.2 The float at the north end of the town floats shall be designated the fishermen's float for use by resident commercial fishermen only and will be marked as such. Skiffs with outboards shall be allowed to tie to this float with a maximum length of 19ft.

CHANGE TO READ 12A AND 12B. 12A-MOVED, 2ND, VOTE, PASSED

To see if the Town will vote to amend the Sorrento Harbor Ordinance by adding Section 6.2.

6.2 The new fishermen's float shall be designated for use only by resident commercial fishermen and will be marked as such. Skiffs with outboards with a maximum skiff length of 19ft. shall be allowed to tie to this float.

13. To see if the Town will vote to change the office of TaxCollector/Treasurer/Clerk from an elected office having a two year term to an office appointed by the Selectboard having a term of one year, effective as of the 2019 annual town meeting. MOVED, 2ND, VOTED, PASSED

- 14. To see if the Town will vote to raise and appropriate \$1,000 to the Shoreline Improvement Account, "SHIP", along with any donations, to maintain, improve and repair the Town's public shoreline property. MOVED, 2ND, VOTED, PASSED
- 15. To see if the Town will vote to raise and appropriate \$5,500 for the Sorrento Community Building to cover running expenses, with any remainder to be transferred into the Community Building Committee's checkbook. **MOVED**, **2**ND, **VOTED**, **PASSED**
- 16. To see if the Town will vote to raise \$5,000 and appropriate \$10,000 from surplus for the Fire Truck Fund. Money from this fund can only be withdrawn by voter appropriation for Fire Truck replacement. MOVED, 2ND, VOTED,PASSED
- 17. To see if the Town will vote to authorize the Selectmen to accept for the Town gifts or grants of money from Federal, State or private sources. MOVED, 2ND, VOTED, PASSED
- 18. To see if the Town will vote to authorize the Selectmen to dispose of all property held by tax liens on such terms as they deem advisable, and execute quit claim deeds for such property providing any such sale is advertised in the Ellsworth American for 30 days and the Sorrento Newsletter for at least one time prior to such sale so that all may have an opportunity to bid on same. MOVED, 2ND, VOTED, PASSED
- 19. To see if the Town will vote to authorize the Selectmen to spend an amount not to exceed ¼ of the budgeted amount in each category of the 2018-2019 fiscal year during the period July 1, 2019 until the annual town meeting for the year 2019. MOVED, 2ND, VOTED, PASSED
- 20. To see if the Town will authorize the Fire Department, with the Selectmen's approval, to dispose of surplus capital equipment in a manner that best benefits the Fire Department.

CHANGE VOTE ON PROPERTY TAX LIMIT TO #21 AND VOTE TO ADJOURN TO #22. PASSED.

21. To see if the town will vote to increase the property tax limit of \$366,669.99 established for Sorrento by state law in the event that the municipal budget approved under the preceding articles will result in a tax commitment that is greater than that property tax levy limit.
