#### **Board of Selectpersons Minutes**

#### **Town Office**

3/5/25

Attending. Hilly Crary (chair), Diana Gazis, Rob Wilpan, four observers in person, and two observers on ZOOM.

Call to order and good news report. The meeting was called to order at 7:00 PM. The good news was that Walsh Engineering will soon put the paperwork for the FEMA project out for bids.

Agenda adjustments. There were no adjustments to the agenda.

Approve minutes of Selectboard meetings on February 19, 2025. A motion was made by Diana and seconded by Rob to approve the minutes of the Selectboard meeting on February 19, 2025. The motion passed unanimously and the minutes were signed.

Approval of Disbursement and Payroll Warrants #17. A motion was made by Rob and seconded by Hilly to approve Disbursement Warrant #17and the associated payroll warrants. The motion passed unanimously, and the warrants were signed.

Community Building update. There is soot in the building because the dampers aren't working properly and allow soot to escape from the burner. Nobody has been able to fix the dampers, so one solution would be to order the necessary parts and put the dampers back on the factory specs. The burner will need replacement in the future and we need to start setting aside money for this purpose.

CEO/LPI. The question of how to determine a flat rate rather than an hourly rate for our new CEO/LPI was discussed. We will wait until we have an estimate of the CEO/LPIs hourly workload before determining a flat rate instead of an hourly.

Welch tree cutting. The object of the tree cutting, as explained by Teresa, would be to preserve saplings and suckers from stumps and then after 5 years look again to see what of the growth could be cut, the object being to protect the waterfront and preserve a view.

Appointed vs. elected fire chief. The majority of the neighboring towns have an appointed rather than an elected fire chief. The advantage of an appointed fire chief would be being able to ensure that the fire chief had the proper certificates of training needed for the job. This is a change that we might consider for the future.

Walsh Engineering/FEMA update. Walsh is ready to accept bids for the FEMA repair work.

Public Comments on Agenda Items. There were no public comments on Agenda Items.

Adjournment. The meeting was adjourned at 7:39 PM.

# Two Lights for Tomorrow

In 2026, the United States will commemorate the 250th anniversary (the "Semiquincentennial") of its founding. This anniversary presents a once-in-a-generation opportunity to share the whole history of our nation and make progress in becoming a more perfect union. To kick-off this commemoration, the Maine Semiquincentennial Commission is participating in **Two Lights for Tomorrow**, a nationwide initiative to commence the celebration of the 250th birthday of the United States of America.

The famous rides of Paul Revere, William Dawes, and others alerting their fellow patriots of the movement of British troops occurred overnight on **April 18–19**, **1775**. A signal – two lanterns in the tower of Christ Church in Boston – indicated that the British regulars were traveling via the Charles River. Two Lights for Tomorrow uses the imagery of that shining light as a uniting call to action for our fellow citizens, no matter where they are, to commemorate and remind ourselves that our history is about working together for a promising future.

# **How Can Your Community Participate?**

All you have to do is **display two lights in your homes**, at your visitor centers, your cultural, historical, and community sites, and in your government buildings on April 18, 2025 to commemorate the beginning of our continual efforts as a nation to work together for a brighter future. There isn't a specific kind of light, duration of display, or location because the important part is just the willingness to participate!

On Friday, April 18<sup>th</sup> you'll have two opportunities to join celebrations in Augusta:



It is hard to believe that we are already looking at the end of March and that we have roughly fifty school days remaining. I'm ready for the green grass and warm temperatures!

The Budget and Finance Committee is almost done with their work of reviewing the various department/school budgets of the district. There is an unavoidable rise in our budget with the majority attributed to the much needed increase to salaries and the anticipated increase in health insurance. The full RSUB will consider and hopefully approve the budget at its April 8th meeting. The District Budget Meeting will take place on May 28th at Sumner starting at 6:30 p.m. If you reside in one of our nine communities, you will be able to vote on the proposed budget at this meeting. The next step in the process is the school budget referendum held on June10th. The referendum vote takes place in each of our communities at the designated voting station. The final budget information will be distributed to our communities after the District Budget Meeting and prior to the referendum and will be accessible on our website.

We are cautiously optimistic that we will get on our baseball and softball fields this spring. We will learn a great deal as we transition into spring and see how the fields bounce back from winter. If you drive by the school, you will notice that the dugouts are nearing completion. Many thanks to the Carpentry Program from Hancock County Technical Center (located at Sumner), as they are putting the finishing touches (roof, siding, paint) on the dugouts.

The spring weather has finally arrived and wildlife is wasting no time shedding winter's grip to enjoy the spring season!

For many of these animals, such as black bears, they have lost a significant amount of body weight and are on the move looking for food after emerging from their winter dens. While denning, black bears enter a state of torpor, slowing their metabolism and respiration, breathing only once per 15 to 45 seconds, and dropping their heart rate to 8-21 beats per minute. Even

with a lowered metabolic rate, bears still lose significant body fat. Unlike true hibernators, bears don't eat, drink, urinate, or defecate during this time.

Once spring comes and bears emerge from their dens, they are working to regulate their bodily functions slowly until normal activity ensues. Bears will seek out limited springtime foods such as insects, grasses, sedges, leftover hard mast from the fall, and other early spring vegetation. While natural foods are limited, bears may take the risk and wander into backyards in search of easily accessible food. It is especially important be proactive about securing and removing backyard attractants this time of year to prevent conflicts with black bears.

# Take steps now to prevent black bears from coming to your yard:



#### Birdseed

- Remove birdfeeders between April 1 and November 1
- Rake up unused bird seed from the ground
- Learn how to plant natural foods to attract birds, not bears



#### Garbage

- Store garbage cans in a building or enclosed by electric fence
- Take to curb on morning of pickup
- Keep dumpster lids and doors closed and latched
- Use bear-resistant dumpsters or garbage cans
- Keep outbuilding and garage doors closed at all times and repair broken windows and doors



#### Grills

- Clean grills thoroughly after use
- Store grill inside when not in use
- If you are having bear conflicts, stop grilling until bear moves on



#### **Pets and Livestock**

- Feed pets inside
- Store livestock and pet food inside
- Keep livestock in buildings at night
- Install and maintain effective fencing for livestock

# Due to ongoing traffic concerns on the Town of Sorrento roads

### Rules and Regulations regarding golf carts on Maine public roads

Golf carts are not allowed on a public road that does not have conspicuous signs placed at regular intervals stating that the road is for golf cart access. These roads are only near golf courses or in areas with a large number of courses.

#### To drive on allowed low speed roads:

The cart must weigh less than 3,000 pounds, must be registered with the <u>local DMV</u> and operated by a licensed driver. This requires you to get the cart inspected to meet federal and state safety standards. At this point, you'll get a VIN and can register and license your cart. Upgrades that you need to add to your cart include windshields, seat belts, stop lights, turn signals, taillights, headlights, reflex reflectors, parking brakes, rearview mirrors, and more. These upgrades must be done according to state and federal law or they may be null and void.

# **Dog Licenses**

\*\*Dogs must be licensed by January 1 of each year or when they reach 6 months of age. \$6 for neutered/spayed... \$11 for unaltered

\*\*Any dog living in the Town of Sorrento must have a <u>Sorrento</u> license/tag.

Please let the Town Office know if your dog is no longer with us

\*\*\*When licensing your dog, you must bring with you your dog's <u>rabies certificate showing the tag number</u> and <u>date of expiration</u> and your <u>certificate of proof of spay or neuter</u>, unless these are already on file at the Town Office.

Online licensing is available October 15 thru January 31 www.apps1.web.maine.gov

Starting February 1 a fine of \$25 will be due along with the registration fee on any unregistered dog. If you no longer own a dog that was registered last year, please call the Town Office to update our records.



#### **EXPIRATION DATES**

<u>VEHICLES:</u> Expire a year from when they are registered (unless you are transferring)

<u>TRAILERS:</u> Can be registered for 1 or 2 years, same month, except over 2000 lb.

Trailers expire in Feb. (1 or 2 years)

BOATS: Expire Dec. 31<sup>st</sup> ATVs: Expire June 30<sup>th</sup> SNOWMOBILES: Expire June 30<sup>th</sup> MOTORCYCLES: Expire March 31 of every year, except antique

# Sorrento Fire Department

#### **BURN PERMITS**

You are required by Maine law to have a permit to burn, even for a small pile of grass clippings or leaves. A Forestry Warden will be called if you burn without a permit, possibly resulting in you being summonsed to court and fined.

The person who signs the fire permit is responsible for the fire. Do not leave any fire unattended.

#### Required for burning:

- \*\*at least two adults to attend the burn,
- \*\*some form of water supply and hand tools must be on hand,
- \*\*and it is recommended you have a cellular phone or other communication device to call for assistance should the fire escape. YOU are responsible to see that the fire is out before leaving.

#### **TAKE NOTE**

#### **BURNING TRASH IS ILLEGAL!!**

State Laws (12 MRSA 9321-25) governing the backyard burning of household trash are enforced by the Maine Forest Service.

If you think someone is burning trash please call 973-3700 immediately! 24 hours/day, 7 days a week.

#### **ONLINE BURNING PERMITS**

Traditional hand-written burn permits are still available, but the state online system allows permits to be acquired 24 hours a day, seven days a week, throughout the state, provided that the fire danger is not high.
